WE MANAGE A COMPETITIVE GRANT MAKING PROCESS EACH YEAR TO SELECT THE MOST IMPACTFUL PROJECTS TO FUND. RESEARCH PROPOSALS ARE REVIEWED BY BOTH NATIONAL SCIENTIFIC REVIEWERS WHO ARE EXPERTS IN THEIR FIELD AS WELL AS CONSUMER REVIEWERS WHO UNDERSTAND THE URGENCY OF FUNDING THAT WILL MAKE A DIFFERENCE TO THE PATIENT COMMUNITY. IN 2018, MOCA PROVIDED A TOTAL OF \$775,000 TO OVARIAN CANCER RESEARCHERS. WE AWARDED \$675,000 TO FIVE OVARIAN CANCER RESEARCH PROJECTS DEVELOPED BY MINNESOTA RESEARCHERS.
